Terms and Conditions

1. These terms and conditions apply to entrants to the '25 Martin Place Dining and Dolce&Gabbana Christmas Instagram Competition' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Property Services Pty Limited (ABN 66 080 918 252). The address is 25 Martin Place, Sydney NSW 2000.
3. This promotion will be conducted on the Instagram page of 25 Martin Place, 25 Martin Place, Sydney NSW 2000, 02 9224 8333. ("Centre").

ELIGIBILITY

4. This Promotion is only open to residents of NSW aged 18 years or over, who are able to attend the Centre and claim the Prize.
5. The following individuals are ineligible to enter the Promotion:
 - a. Directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

6. This Promotion commences at 10.00am AEDT on Friday 21 November 2025 and ends at 5pm AEDT on Thursday 18 December 2025 ("Promotion Period").

HOW TO ENTER

7. To enter this Promotion, eligible individuals must, during the Promotion Period:

 - b. Like the competition post
 - c. Comment on the competition post, tagging a friend
 - d. The tagged friend must also follow the @25martinplace Instagram account

LIMITS ON ENTRY

8. Unlimited entries. Every comment and unique friend tag is a new entry. Each entry must be submitted separately in accordance with these Terms and Conditions.

PRIZE DETERMINATION - GAME OF CHANCE

9. The draw will take place at ID Collective, Level 5, 32 Carrington Street, Sydney NSW 2000 at 9am AEDT on Friday 19 December 2025. The Promoter may draw reserve entries and record them in order in case of an invalid entry/entrant or a prize is unclaimed.

12. The provisional winner will be notified via Instagram direct message, and once contact details are provided by phone or email within 7 days of determination. PRIZE CONDITIONS

15. Prize No. 1 is subject to the following conditions:
 - a. The following applies to the Dolce&Gabbana Gift Certificate:
 - i. The Dolce&Gabbana Gift Certificate is treated as cash and cannot be replaced if lost or stolen.
 - ii. The Gift Certificate may only be used for purchases in the Dolce&Gabbana 25 Martin Place, Sydney exclusively and cannot be returned or exchanged for cash.
 - iii. The name of the winning recipient will be provided to the Dolce&Gabbana 25 Martin Place, Sydney boutique for verification purposes.
 - iv. Gift Certificates cannot be redeemed online.
 - v. No change is given and any balance that remains on the card can be used in whole or part against future purchases in Dolce&Gabbana 25 Martin Place, Sydney boutique.
 - vi. Gift Certificate expires 12 months after issue. Any balance that remains on the Gift

Certificate after expiry will not be available for use.

- vii. The Dolce&Gabbana Gift Certificate cannot be redeemed by telephone/mail order.
- viii. Gift Certificates are not transferable.
- ix. Gift Certificate is valid on full price items only.
- x. Items are considered final sale and cannot be returned, exchanged, or refunded.
- xi. Alteration charges are not included.

- b. The following applies to the 25 Martin Place e-Gift Card
 - i. Any ancillary costs associated with redeeming the 25 Martin Place Pays-Enabled Digital Prepaid Gift Card (“e-Gift Card”) are not included. The e-Gift Card must be activated within 2 months of issue and is valid for 12 months after activation. At expiry of the e-Gift Card any unused balance will be forfeited. Eligible Customers will not receive notice prior to expiry. Card expiry and balance can be found on your mobile device in the Vault Payments App. The e-Gift Card is issued by EML Payment Solutions Limited ABN 30 131 436 532 AFSL 404131 (“EML”) and distributed by Vault Payment Solutions Group Pty Ltd, ABN 66 632 373 105 (“Vault”). See www.vaultps.com.au/terms-conditions for terms and conditions.
 - ii. The 25 Martin Place e-Gift Card can only be used at participating 25 Martin Place retailers, see Annexure 1.

16. To activate your 25 Martin Place e-Gift Card:

- a. Click on the link in the text message to ‘Redeem’ your 25 Martin Place e-Gift Card. You have 2 months from the issuance date to activate the e-Gift Card.
- b. You must have an Australian mobile number to activate.
- c. You may need to enter your mobile number and the activation code that was provided in the SMS.
- d. When your 25 Martin Place e-Gift Card is displayed, click “Add card to wallet” and follow the prompts to add your e-Gift Card to your phone’s mobile wallet (e.g. Apple Pay, Google Pay or Samsung Pay).
- e. Use the card in the mobile wallet for purchasing goods and services in the participating stores within the Shopping Centre associated with your claim.
- f. Once activated you have 12 months to use your e-Gift Card. You can check the balance and the expiry date of your card by returning to the link in the SMS and following the steps. Should you have multiple cards, you can view and manage all cards by downloading the Vault Payments App.

UNCLAIMED PRIZES

17. Any prize that has been won but remains unclaimed will be entered into the unclaimed prize draw. The unclaimed prize draw will take place at the same time and place as the original draw, on Monday 19 January 2026. The winner will be notified via Instagram direct message, and once contact details are provided by phone or email. GENERAL

18. You must not:

- a. tamper with the entry process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the entry process);
- b. engage in any conduct that may jeopardise the fair and proper conduct of this Promotion;
- c. act in a disruptive, annoying, threatening, abusive or harassing manner;
- d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this Promotion;
- e. breach any law;

30. Entrants consent to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter or the Promoter's retailer(s).
31. The Promoter reserves the right, at any time, to verify the validity of entries (including contacting participating retailers) and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
32. If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify an entrant engaging in unauthorised intervention or fraud; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
33. If any dispute arises concerning the conduct of this promotion, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.
34. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.
35. Your entry must be received during the Promotion Period and will be deemed to be received only when received by the Promoter. Where relevant, entry forms/scratch cards from any other competition cannot be used for this competition, and are void if copied, forged, stolen or interfered with. If online or SMS entry is available, you will receive a return message confirming your entry. You are responsible for your own costs associated with entering. If you enter using multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.
36. The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. If for GST purposes this Promotion results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Australian Competition and Consumer Act 2010* (Cth), as well as any other implied warranties under similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees").

38. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
- a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the prize value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by an entrant or winner; or
 - f. use of the prize,

except for any liability which under statute, including under the Non-Excludable Guarantees, cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).

39. This Promotion is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

40. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, if required, to Australian regulatory authorities. Participation in the Promotion is conditional on providing this information.
41. By entering, you consent to the Promoter using this information for promotional, marketing, publicity and research purposes, including telephoning the entrant or sending email or SMS messages provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You also consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this competition.
